TERMS AND CONDITIONS OF VOTING MEMBER DOJANG (VMD) STATUS OF THE NEWFOUNDLAND AND LABRADOR TAEKWONDO UNION INC. (NLATU):

- 1. The VMD owner / head instructor agrees to read, understand and abide by all the rules and regulations of the NLATU which includes the bylaws and all policies.
- 2. It is the responsibility of the club owner / head instructor to register and renew VMD status on an annual basis and, if required, register the VMD with Taekwondo Canada.
- 3. Upon approval of VMD status, the club owner / head instructor must register all individual members within that VMD with the NLATU and if required, Taekwondo Canada
- 4. It is the responsibility of the club owner / head instructor to ensure that all instructors and coaches are registered with the NLATU and, if required, Taekwondo Canada.
- 5. Only the individually registered members, instructors and coaches are covered under the insurance policy.
- 6. It is the responsibility of the VMD owner / head instructor to communicate with their own individual members with regard to all NLATU matters. The NLATU shall communicate with individual members via the VMD.
- 7. It is the responsibility of the VMD owner / head instructor to ensure that no individual member of the VMD and the VMD itself, participate in non-sanctioned NLATU events, including officiating, coaching, assisting and sponsoring.

RELEASE OF LIABILITY AND WAIVER OF CLAIMS

This is a legally binding Consent Form and Release of Liability made voluntarily by me, the undersigned Releasor, on my own behalf, and on the behalf of my heirs, executors, administrators, legal representatives and assigns to Newfoundland and Labrador Amateur Taekwondo Union Inc. (NLATU).
